What is the aim of the project idea? (What are the issues, problems, opportunities you want to address?)	The project proposal aims at improving capacities of public and private operators of cultural and creative sector (CCS) in order to increase its economic relevance especially through transnational cooperation. Central Europe has a great richness in terms of cultural resources; these represent not only important factors for the attractiveness of Central Europe's territory, but can also be considered as key elements for relaunching the economy of many Central Europe territories. Improving capacities of CCS operators is essential for a long-lasting valorisation strategy of cultural resources and can represent a powerful engine for economic growth. The project idea starts from the fact that the cultural and creative sector (CCS) has, in many Central Europe countries, a social and economic impact far below its potential, despite its economic potential importance. This depends mainly from three issues: 1. lack of skills and competences of CCS operator; 2. lack of funds and difficulties to access to financial resources by CCS operators; 3. lack of policies and coordinated strategies next to inadequate interaction among CCS operators and local/regional authorities and policy makers and among CCS operations at international level It is believed that these challenges could be successfully faced through a transnational cooperation approach.
What are the planned activities and expected results?	The most important goal is to develop and disseminate an environment conducive to creative industries. Expected results: 1. increased entrepreneurial skills and competence of CCS operators; 2. positive condition to attract investment (including increased awareness of financial operators over economic value of CCS) 3. integrated policies, coordinated strategies supporting authorities, policy makers and CCS operators; 4. transnational marketing and networking among CCS operators. Planned

activities: mapping CCS; develop governance models to pinpoints successful

	factors guaranteeing creation of conducive environment for CC industries; governance models should also find out innovative management models to test; coordinated strategies supporting local/regional authorities and policy makers to steer the CCS sector; ICT tools to increase visibility and networking of CC operators; training seminars addressed to CC operators, policy makers, financial operators.
